BOM proposes bylaw changes

PROPOSED Constitution and By-Law Changes: At the 3 October Board of Managers meeting, the following changes to the ALSSAR Constitution and By-law were discussed and approved. A motion was made to forward these changes to the Annual Meeting with a recommendation of approval by the general membership. It was felt these changes would improve the general governance of the society and help codify existing procedures. In accordance with the ALSSAR Constitution and By-laws, these proposed changes are presented here for review by the membership:

CONSTITUTION, Article III, Eligibility for Membership

The NSSAR is responsible for establishing the classes of memberships; recent changes by the NSSAR have rendered those in the ALSSAR Constitution outdated. The following represents the currently approved classes of membership.

There shall be the following classes of members:

(1) A Regular or Regular Life Member shall be any member of the age of eighteen years and over, excepting those members described in Subsections (2) through (4) of this Paragraph, who meets all the requirements for membership as defined in this Constitution and in the Bylaws of the National Society.

(2) A Youth Registrant shall be a male under the age of eighteen years whose Youth Registrant application has been submitted and approved in accordance with the Bylaws of the National Society.

(3) A Youth Life Member shall be a male under the age of eighteen years who has applied for and been admitted to Youth Life Membership and has paid the applicable fee for Life Membership.

(4) A Junior Member is a male under the age of eighteen years who has met the membership requirements of the Sons of the American Revolution. A Junior Member cannot vote or receive *The SAR Magazine* until he attains the age of eighteen years.

(5) A Memorial Membership for a deceased male of the same family as current members, whose application has been submitted and approved in accordance with the Bylaws of the National Society.

JUSTIFICATION: These are the current classes of membership recognized by the National Society and taken from the current National Society Handbook.

CONSTITUTION, ARTICLE V, Meetings, Sec 1 (current wording)

SECTION 1. The Annual Meeting of the Society for the election of officers and transaction of business shall take place on a Saturday within thirty days prior to or following the birth date of George Washington, being the 22nd day of February. The specific date selection shall be made by the President of the Society. The Board of Managers will meet at least two times a year at the call of the Presi-

dent who shall select the date and place of the meeting. Special meetings may be called by the President subject to the approval of the Board of Managers or by written request of at least seven (7) members of the Board of Managers.

ADD: At the end of Section 1: **The State Secretary shall provide written notice to board members of the time and place of a Board of Managers meeting not less than thirty days prior to a scheduled meeting and not less than fifteen days prior to a Special Board of Managers meeting. The General Membership shall be notified of the time and place of the annual meeting not less than thirty days prior to the meeting.**

JUSTIFICATION: This addition, by and large, does nothing but codify what is currently done. The one exception is to establish a 15-day notification requirement for a Special Board of Managers meeting. If something has occurred that requires the calling of a Special Board of Managers meeting and immediate action, then certainly a shorter timeframe for notification is warranted. There is currently no mention of a time frame for any notice being provided within the Constitution and By-Laws.

CONSTITUTION, ARTICLE V, Meetings, Sec 2 (current wording)
SECTION 2. There shall be one delegate at large, one delegate for every fifty members, and one delegate for the remaining twenty-five or more additional members, to represent the Society at the next National Congress of the Society thereafter. In addition there shall be nominated a National Trustee and an Alternate National Trustee to represent the Society at all meetings of the Trustees of the National Society during the following year. The National Trustee and Alternate National Trustee shall be elected and installed in office during the annual National Society Congress.

Bylaws

DELETE SECTION 2 TOTALLY AND REPLACE WITH:

SECTION 2. At the last meeting of the Board of Managers prior to the Annual Meeting the President shall appoint a Nominating Committee of three (3) Past Presidents of the Society who, in the opinion of the President, are active in the affairs of the Society. The President shall strive, in the appointment of the Nominating Committee, for the widest possible geographic distribution of membership on the Committee. The Committee shall be chaired by the most recent Past President who is willing and able to serve. It shall be the duty of the Nominating Committee to nominate a candidate, who shall be a primary member in good standing of the ALSSAR, for each office enumerated in Section 1 Article IV of the Constitution and a member of the Endowment Fund Committee as outlined in Article VI of the Constitution, and to report its nominations to the President and the Secretary in sufficient time for the report to be included in the Notice of the Annual Meeting provided to the general membership. In addition to nominating the state officers, the Nominating Committee shall, in its report, nominate one candidate each for the offices of National Trustee and Alternate National Trustee as provided for in the Constitution and By-Laws of the National Society. The National Trustee and Alternate National Trustee shall be elected and installed in office during the annual National Society Congress.

ADD: as new Section 5: (NO SECTION FIVE CURRENTLY EXISTS)

Section 5: Delegates to the National Society Sons of the American Revolution Annual Congress will be elected at the Board of Managers meeting prior to the Annual National Congress. The State Secretary will forward the names of elected delegates to the National Society so that the appropriate credentials can be provided. There shall be one delegate at large, one delegate for every fifty members, and one delegate for the remaining twenty-five or more additional members, to represent the Society at the next National Congress of the Society.

JUSTIFICATION: The change to section 2 allows for much of what is currently done to be codified into the Constitution of the society. It provides that all officers are primary members of the State Society and thus will appear on the ALSSAR roster maintained by national while providing the State President with some degree flexibility in appointing a nominating committee. The new section five incorporates some of the old section 2 while establishing when delegates are elected.

BY-LAWS, ARTICLE IV, Removals from Office and Suspension or Expulsion of Members (current wording)

SECTION 1. Any member of the Board of Managers or elected Society officer may be removed therefrom by a vote of two-thirds of those members of the Board of Managers **currently elected thereto**, but only at a special meeting of the Board of Managers called for that purpose.

REMOVE: "currently elected thereto"

INSERT: "Present"

BY-LAW ARTICLE IV, SECTION I, to read: Any member of the Board of Managers or elected Society officer may be removed therefrom by a vote of two-thirds of those members of the Board of Managers **present**, but only at a special meeting of the Board of Managers called for that purpose.

JUSTIFICATION:

Within the ALSSAR Constitution and by-laws there are several references (by-law Article IV, section 2 dealing with expulsion of a member, By-law XXII, dealing with amendments) where the requirement to approve is a vote of two-thirds of those **members present**.

As written By-Law Article IV, Section I, it is in conflict with the ALSSAR Constitution's Article 5, section 4, which indicates a quorum at a Board of Managers meeting, is ten members of the Society in good standing. By definition a quorum is that number needed to conduct business. As written this by-law would indicate that a quorum would be in excess of 50 members and would include two members from each chapter, all state officers, and all past presidents in good standing – a meeting that could never be attained. Given the Constitution takes precedence, this change is needed to bring the by-law into conformity with the ALSSAR Constitution.

BY-LAWS, ARTICLE X, The Secretary (current wording)

The Secretary shall conduct the general correspondence of the Society and shall maintain appropriate files. He shall have charge of and maintain all records of the Society, which are not herein expressly placed in the charge of other officers of the Society. On or about January 15 of each year he shall collect from the other officers who keep records, the retained copies of applications for membership and the historical records of the Society and may deposit the same in an appropriate archival institutions approved by the Board of Managers. He shall notify all candidates of their admission to membership in the Society and forward to them their certificates of membership. He shall maintain an accurate roll of membership of the Society and shall as of January 1 of each year, submit the report of membership of the Society to the **Executive Secretary** of the National Society. He shall, under direction of the President, give due notice of the time and place of all meetings of the Society and of the Board of Managers and shall attend same.

CHANGE: Executive Secretary to **Executive Director: Justification:** the Executive Director is his proper title; there is no executive secretary.

ADD THE FOLLOWING AT THE END OF THE SECTION: He shall prepare minutes of all society meetings which will be available to members of the Board of Managers not later than forty-five days following the adjournment of the meeting.

JUSTIFICATION: One of the presumed duties of any secretary is the preparation of minutes of all official meetings. However, nowhere in the existing constitution and by-laws is this subject addressed. The minutes represent official guidelines established by the Board of Managers for conducting state business and are essential to the leadership of the society. These need to be completed as soon as possible and provided to the leadership for possible transcription errors, and to provide guidance to the chapters and to committee chairman. The 45-day timeframe was utilized, as this is the standard set by the National Society Headquarters for the filing of National Committee Minutes with the Headquarters.

BY-LAWS, ARTICLE XV The Chancellor (current wording)

The Chancellor shall be an attorney at law and it shall be his duty to give his opinion on legal questions affecting the Society when such questions are referred to him by the **proper officers**.

Replace with:

The Chancellor shall be an attorney at law and it shall be his duty to give his opinion on legal questions affecting the Society when such questions are referred to him by the Society President, or the Senior Vice President in those cases where the subject of the inquiry is the Society President. He will review and maintain a copy of all chapter constitutions and by-laws.

JUSTIFICATION: More clearly defines who may request a legal opinion from the society chancellor.

BOM approves 2010 budget, endorses national officers

A total of 29 compatriots attended the fall meeting of the ALSAR Board of Managers in October at the MAX Federal Credit Union building in Montgomery.

During the meeting, ALSSAR secretary Bob Thomas announced to President John Killian that he would be resigning his position immediately for personal reasons. Killian asked vice-president Bruce Pickette to keep the minutes of the meeting and later appointed John Wallace to complete the term.

The registrar, compatriot Ron Bearden, noted his report in the BOM book. In discussing the "Center Check" issue, he noted the outcome of votes, challenges to policy, and Blue Ribbon panels was that there would be no change in current policy; the SAR will NOT accept applications based upon "Center Checked" DAR Record Copies. However, there will be some "grandmothering" allowing admission of sons, grandsons, nephews, etc., of DAR members based upon their DAR Record Copy, provided the record copy is NOT "Center Checked." This will be the same as the current SAR policy which allows for sons, grandsons, nephews, etc. of SAR members to become members based upon an existing SAR Record Copy. The lineage or service of the Patriot cannot be in question by either the SAR or DAR. Basically, this is for new applicants who are using older record copies which are not well documented.

Compatriot Tony Neathery, chairman of the ROTC-JROTC committee, stated that several JROTC High School programs are not covered by the ALSSAR and requested chapters complete a questionnaire that he will have in their package to be handed out at the state convention.

Compatriot John Bryan, chairman of the American History Teacher of the Year committee, requested chapters fax information about the contest to their local school boards.

Compatriot Bruce Pickette, chairman of the Americanism committee, noted the theme for this year's Americanism Elementary School Poster Contest is "The Battle of Bunker Hill."

Compatriot Johnny Curry of the American Village thanked the ALSSAR for its support on Memorial Day and at July 4 activities. He noted this July 4 will be the 10th anniversary of the Village and that a 9-foot reproduction of the Landsdowne portrait of George Washington will be hung in the new ballroom.

Compatriot Curry reported that burials at the new National Cemetery began on June 24 and there are 124 veterans now buried there.

Compatriot Jim Wardlaw of the Public Services and Heroism committee, said he had sent a letter to all chapters requesting he be informed of recognitions given but he had had no response. He remarked that the Gen. Galvez chapter recognizes local citizens at all opportunities and surely some chapters have awarded medals or certificates to report.

President Killian recognized ladies auxiliary president Abby Alexander who requested the ladies in the chapters put together a basket to be used as door prizes at the state convention in Birmingham. She reported that the auxiliary had presented a \$250 check to add to their donation to the Center of Advancing America's Heritage.

Compatriot Rod Hildreth presented the 2010 budget forecast and stated his opinion that every time national or state dues and fees are raised the result is a loss of membership. The attendees voted to change some of the recommendations of the committee. The budget forecast was unanimously accepted. The final forecast included \$509 designated as a "contingency fund."

President Killian asked compatriot Johnny Curry for an update on the "Revolutionary War in Alabama" brochure that the committee has been working on. Curry presented a "mock-up" of a proposal for one side of the brochure which can be also used as a school classroom poster that could be distributed to schools near each SAR chapter. Anyone with suggestions for the brochure should contact one of the committee members.

Compatriot Pickette explained there were several changes to both the Constitution and By-Laws proposed by the appointed committee, chaired by Wallace. Those changes approved by the BOM were to be forwarded to the general membership to be voted upon during the annual meeting. Those changes are included in this newsletter.

As a result of discussions during the business of the 2010 budget forecast, compatriot Lee Swart moved the ALSASR donate \$250 for a flag pole on the Avenue of Flags being constructed at the Alabama National Cemetery located next to the American Village. Donations to the Flag Pole Project should be mailed to the Cemetery Support Committee, Alabama National Cemetery, P. O. Box 648, Montevallo, Alabama 35115.

The Board of Managers also voted to endorse all unopposed candidates for national office, as well as Joe Dooley as Genealogist General.
