

APPLICATION FOR CHARTER

The First Day of September, 2011

To the Board of Managers of the Alabama Society of the Sons of the American Revolution:

COMPATRIOTS: The members of the Alabama Society of the Sons of the American Revolution residing in the Shoals area of Northwest Alabama, along with the undersigned officers of this provisional chapter respectfully apply for the privilege of organizing a chapter within the State of Alabama, in pursuance of and according to Bylaw No. 2, Section 6, of the National Society, and in accordance with Article VI of the By-Laws of the Alabama Society, Sons of the American Revolution.

The chapter, which shall hereafter be known as the Shoals Area Chapter, shall have its headquarters in the Florence/Sheffield/Tuscumbia/Muscle Shoals area, or at such other place within the said area as may hereafter be determined by members of the said chapter. Monthly meetings will be held on the second Sunday afternoon of each month, at 2:00 PM, with the exception of June, July, and August, at the Sheffield Public Library in Sheffield, AL or as hereafter may be determined by members of the said chapter.
